THE CONSTITUTIONAL AMENDMENT PROTECTING THE RIGHT TO ENGAGE IN FARMING, RANCHING, TIMBER PRODUCTION, HORTICULTURE, AND WILDLIFE MANAGEMENT.

THE CONSTITUTIONAL AMENDMENT TO AUTHORIZE THE LEGISLATURE TO ESTABLISH A TEMPORARY LIMIT ON THE MAXIMUM APPRAISED VALUE OF REAL PROPERTY OTHER THAN A RESIDENCE HOMESTEAD FOR AD VALOREM TAX PURPOSES; TO INCREASE THE AMOUNT OF THE EXEMPTION FROM AD VALOREM TAXATION BY A SCHOOL DISTRICT APPLICABLE TO RESIDENCE HOMESTEADS FROM \$40,000 TO \$100,000; TO ADJUST THE AMOUNT OF THE LIMITATION ON SCHOOL DISTRICT AD VALOREM TAXES IMPOSED ON THE RESIDENCE HOMESTEADS OF THE ELDERLY OR DISABLED TO REFLECT INCREASES IN CERTAIN EXEMPTION AMOUNTS; TO EXCEPT CERTAIN APPROPRIATIONS TO PAY FOR AD VALOREM TAX RELIEF FROM THE CONSTITUTIONAL LIMITATION ON THE RATE OF GROWTH OF APPROPRIATIONS; AND TO AUTHORIZE THE LEGISLATURE TO PROVIDE FOR A FOUR-YEAR TERM OF OFFICE FOR A MEMBER OF THE BOARD OF DIRECTORS OF CERTAIN APPRAISAL DISTRICTS.

憲法修正案授權立法機構對不屬從價稅徵收住宅用地的不動產的最高估價設定臨時限制；增加適用於住宅用地的學區從價免稅額（從 40,000 美元提高到 100,000 美元）；調整對老年人或殘障者住宅用地徵收的學區從價稅限額，以落實某些免稅額的增加；從憲法對撥款增長率的限制中排除某些用於支付從價稅收減免的撥款；並授權立法機構規定某些評估學區的董事會成員的任期為四年。
