All agenda items are subject to action. The Committee reserves the right to meet in closed session on any agenda item should the need arise and if applicable pursuant to authorization by Title 5, Chapter 551, of the Texas Government Code.

Pursuant to Section 418.016 of the Texas Government Code, on March 16, 2020, the Governor of the State of Texas granted the Office of the Attorney General's request for the temporary suspension of certain provisions of the Texas Open Meetings Act to allow for telephonic or videoconference meetings of governmental bodies that are accessible to the public in an effort to reduce in-person meetings that assemble large groups of people, as a precautionary measure to contain the spread of novel coronavirus COVID-19.

# MINUTES OF THE MEETING OF THE JERSEY VILLAGE COMPREHENSIVE PLANNING UPDATE COMMITTEE

# November 19, 2020 – 7:00 p.m.

A quorum of the Comprehensive Planning Update Committee of the City of Jersey Village, Texas, convened on November 19, 2020, at 7:00 p.m. via videoconference.

A. The meeting was called to order by Dr. Courtney Standlee at 7:07 p.m. and roll was taken. The following Committee members were present for the meeting:

Debra Mergel, Ashley Hart, Gabriella Hall, Jennifer McCrea, and Amy Weyer were not present at this meeting.

City Staff in attendance: Austin Bleess; City Manager, Harry Ward; Director of Public Works, Christian Somers; Building Official, and Danielle Cordova; Administrative Secretary.

Also in attendance: Council Liaison Drew Wasson.

1. Designate alternate members to serve in place of any absent Committee Members.

No action was taken.

### **B.** Citizen's Comments

No action was taken; there were no comments from citizens.

C. Consider approval of the Minutes for the Regular Meeting held on November 12, 2020.

Brittany Davies moved to approve the minutes of the meeting held on November 12, 2020. Judy Tidwell seconded the motion.

All were in favor; the motion carried.

D. Discuss and take appropriate action regarding a review of the City's 2016 Comprehensive Plan in order to recommend changes to the planning and zoning commission in accordance with Section 14-23(d)(4) of the Code of Ordinances.

The Committee held discussion on Chapter 8: Community Facilities of the City's 2016 Comprehensive Plan. Committee members identified the following changes to the chapter:

- Add water plants/ wastewater treatment plants to the list of the city's primary buildings
- Add dates each city facility was built/established in the summary of findings section
- Correct typo in "apparatus" under fire station section
- Indicate that the golf course cart barn is to be replaced after a new clubhouse is built to coordinate with the look and feel of the new facility
- Indicate that the aesthetics of the golf course maintenance building are to be maintained and improved
- Indicate that the issues regarding the storage of hydraulic oil and chemicals have been addressed
- Update pictures for deficiencies identified at city hall
- Add/remove items that have been/need to be updated at each city facility
- Indicate that improvements will be made where they are suitable without over spending until a transition can be made to the new city hall
- Replace the heading "City Maintenance Staff Buildings" with "Public Works/ Parks Buildings"
- Incorporate details from the purchase of the Public Works facility at 12527 Taylor Rd.
- Add a section for facilities that city employees maintain (i.e. water treatment facilities, pool facilities, etc.), identify their purpose, and possible problems
- Indicate that the Capital Improvements Plan is evaluated annually

Dr. Standlee proceeded the discussion to Chapter 9: Implementation Plan of the City's 2016 Comprehensive Plan. The Committee identified the following changes to the chapter:

- Reference FEMA grants, berm project, and green spaces to maintain the city's AA+ rating in the Sustainment of Core Activities section
- Title the city council figure on page 170 of the Comprehensive Plan and incorporate checks, balances, and collaboration
- Remove the term "individual" in training workshops on page 22
- Replace the term "annual review" with "periodic review" on page 23
- Remove paragraph on right hand side of page 174, summarize, and incorporate details into figure 9.1
- Update Priority Recommendations table, prioritize current items, and incorporate accomplishments from the last four years
- Incorporate a figure that can represent the text within the Financing the Comprehensive Plan section
- Update the years in implementation matrix
- Reformat Future Land Use Recommendations table to correspond with the Priority Recommendations table

City Manager Bleess indicated a draft of the revised Comprehensive Plan will be sent to the Committee by December 10, 2020 and requested that written comments be returned by December 15, 2020.

With no further discussion, Dr. Standlee proceeded to the next agenda item.
